How and where can you use your certification marks?

The table below summarizes the allowable limits for use of certification marks.

| On product or primary (display or retail) packaging | Not allowed | Not allowed |
| On larger boxes, etc. used for transportation of products (secondary or transit packaging) | Not allowed | Allowed |
| On vehicles or permanent structures such as buildings for advertisement | Allowed | Allowed |
| On brochures, website, in advertising... | Allowed | Allowed |

Suspension Or revocation of permission to use mark or logo

TKLCER retains the right, at its sole discretion, to suspend or revoke any permission to use its certification mark or logo. In most circumstances, when TKLCER is informed that a person is misusing the certification mark or logo, TKLCER Will provide the person notice of the misuse and a reasonable opportunity to comply with TKLCER `s Rules and guidelines. However, TKLCER retains the right to suspend or revoke privileges without notice and an opportunity to correct, particularly when the violation is of a gross nature and more immediate action is necessary to stop misuse.

Actions by TKLCER To suspend or revoke use of the certification mark shall be communicated in writing to the person whose privileges are being suspended or revoked and to all other persons affected by the decision. TKLCER May also publicize its actions on its website and any other of its publications. Should Any person continue use of TKLCER Mark or logo after notice of suspension or revocation, TKLCER will seek full equitable and/or legal remedies through a court of competent jurisdiction.
